

The Rules for Admission Procedure and Conditions for Admission to Study in the Lifelong Learning Programmes - U3V - at the Faculty of Mining and Geology at VŠB - Technical University of Ostrava for the academic year 2020/2021

The Faculty of Mining and Geology (HGF) has announced **the admission procedure** starting on 1 January 2020 for the study in the consultation centre Ostrava in **the academic year 2020/2021** in the lifelong learning - study U3V.

1 Lifelong learning - study U3V

1.1. Consultation centre

Teaching is done only in the consultation centre Ostrava in the following degree programme:

- Basic of geology - The maximum number of students in one programme is 25. (instruction in the Czech language)
- Applied geology - The maximum number of students in one programme is 25. (instruction in the Czech language)
- Company and Natural sciences - The maximum number of students in one programme is 40. (instruction in the Czech language)
- Company and Geosciences - The maximum number of students in one programme is 40. (instruction in the Czech language)

1.2 The method and conditions of submitting the application for the lifelong learning – U3V

- The application must be submitted on the printed form, it must be signed by the candidate and personally delivered to the U3V coordinator to the Geological Pavilion.
- The application must be attached with a copy of the secondary school leaving certificate.
- The date for submitting applications is from **1 June 2020 to 31 August 2020**.
- The study fee for one academic year is CZK 1,000. The amount must be paid in cash at the time of submission of the application at the Geological Pavilion to the U3V coordinator.
- In the event of failure to comply with these conditions, the application will be removed from the admission procedure.

1.3 Entrance examination

The entrance examination for admission to the study is waived. Candidates are admitted on the basis of a proven interest in this form of education in the order in which they have applied for the study up to filling the capacity of the degree programme. The prerequisite for the admission to the 2nd year of the study is completion of the 1st year of this programme.
